thence in a southerly direction along the town line between the Town of Paris and the Town of Sumner to a granite marker defining the southwesterly corner of the Town of Sumner; thence south 20° 30' east for a distance of 3,100 feet, more or less, to a marker on the northwesterly corner of the Town of Buckfield; thence southerly to the point of beginning, together with the inhabitants thereof, is hereby incorporated into a town by the name of West Paris; and said Town of West Paris is hereby invested with all the powers and privileges and subject to all the duties and obligations incident to other towns of the State.

Chapter 55

AN ACT Relating to Costs of Flander's Bay Community School District.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1951, c. 203, amended. Chapter 203 of the private and special laws of 1951 is amended by adding at the end the following new sentence:

Any funds received by the Flander's Bay Community School District under P. L. 874, Aid to Schools in Federally Affected Areas, shall be credited to the assessment of the individual towns where the students reside.

Chapter 56

AN ACT Permitting Town of Brunswick to Raise Money for Boarding Home.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment of the Legislature unless enacted as emergencies; and

Whereas, a boarding home operated in a structure owned by the Town of Brunswick will be closed early in 1967 because of Maine Department of Health and Welfare regulations governing boarding homes; and

Whereas, there is a lack of boarding home facilities in Brunswick; and

Whereas, many residents of said boarding home are residents of Brunswick, have limited income, and will have to be placed in homes in other towns against their wishes, and in so doing will have to be separated from each other, all because of the lack of boarding home facilities in Brunswick; and

Whereas, for these reasons there is a need for designing and constructing a boarding home facility as early as possible in 1967; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Brunswick to raise money for boarding home. The Town of Brunswick, Cumberland County, may raise or appropriate money to provide for or support a boarding home in the Town of Brunswick for the housing, board and care of human beings, regardless of race, creed, color or religion, provided that said boarding home shall be organized under the Revised Statutes of 1964, Title 13. The Town of Brunswick shall have a lien on such boarding home equal to the amount of money appropriated and turned over in the aggregate by the Town of Brunswick to the said boarding home, which lien may be enforced in the same manner and with the same effect as the lien on real estate set forth in the Revised Statutes of 1964, Title 36, section 943, whenever the said boarding home ceases to be a boarding home organized under said Revised Statutes of 1964, Title 13.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

Chapter 57

AN ACT Providing for a Council-Manager Charter of Town of Gorham.

Be it enacted by the People of the State of Maine, as follows:

COUNCIL-MANAGER CHARTER OF TOWN OF GORHAM

ARTICLE I

GRANT OF POWERS TO THE TOWN

Sec. 101. Incorporation. The inhabitants of the Town of Gorham, within the limits as now established or as hereafter established in the manner provided by law, shall be a municipal corporation by the name of the Town of Gorham, Maine.

Sec. 102. Powers of the town. The town shall have, exercise and enjoy all the rights, immunities, powers, privileges and franchises, and shall be subject to all duties, liabilities and obligations provided for herein, or otherwise pertaining to or incumbent upon said town as a municipal corporation, or the inhabitants or municipal authorities thereof; it may enact bylaws, regulations and ordinances not inconsistent with the Constitution and laws of the State of Maine, and impose penalties for the breach thereof not exceeding \$100 in any one case, to be recovered to the use of said town by appropriate action.

The town may acquire property within or without its corporate limits for any town purpose, in fee simple or any lesser interest or estate, by purchase, gift,
