## Chapter 51

### AN ACT Relating to the Registration of Interstate Motor Carriers.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 35, § 1556, amended.** The first sentence of section 1556 of Title 35 of the Revised Statutes is amended to read as follows:

In order that there may be proper supervision and control of the use of the highways of this State, every person, firm or corporation transporting freight or merchandise for hire by motor vehicle upon the public highways of this State **between points within this State**, between points within and points without the State or between points without the State but passing through this State is required to obtain a permit for such operation from the commission.

Effective October 1, 1969

## Chapter 52

### AN ACT Relating to Jurisdiction of Juvenile Courts Over Offenses in Operating Boats.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 15, § 2552, amended.** The last paragraph of section 2552 of Title 15 of the Revised Statutes is amended to read as follows:

Juvenile courts shall have no jurisdiction over offenses in which any juvenile is charged with the violation of any provision of Title 29 and Title 38, chapter 1, subchapter VI, or over any other traffic law or ordinance, if such offense is a misdemeanor, except that juvenile courts shall have exclusive, original jurisdiction over offenses in which any juvenile is charged with a violation of Title 29, sections 900, 1312, 1315 and 1316, or of Title 38, section 237, subsection 2.

### AN ACT Relating to Appointment and Duties of Deputy Attorneys General and Assistant Attorneys General.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., T. 5, § 196, amended.** Section 196 of Title 5 of the Revised Statutes is amended to read as follows:
