## Chapter 72

### AN ACT to Make Ballot Tampering a Felony.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., T. 21, § 1579, sub-§ 22, repealed. Subsection 22 of section 1579 of Title 21 of the Revised Statutes is repealed, as follows:

~~22. Tampering with ballots. A person who tampers with ballots or checklists or who breaks a seal or opens any sealed box or package of ballots or checklists, except as permitted by this Title;~~

Sec. 2. R. S., T. 21, § 1580, sub-§ 9, additional. Section 1580 of Title 21 of the Revised Statutes, as amended, is further amended by adding a new subsection 9, to read as follows:

9. Tampering with ballots. A person who tampers with ballots or checklists or who breaks a seal or opens any sealed box or package of ballots or checklists, except as permitted by this Title.

## Chapter 73

### AN ACT Relating to Sick Leave for Teachers Assistants and Aides.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., T. 20, § 1951, amended. Section 1951 of Title 20 of the Revised Statutes, as amended by chapter 61 of the public laws of 1967, is further amended to read as follows:

#### § 1951. Minimum sick leave

Each administrative unit operating public schools within the State shall grant all certified teachers, except substitute teachers as defined by the commissioner, a minimum annual sick leave of 10 school days accumulative to a minimum of 90 school days without loss of salary. Any other plan of sick leave which, in the opinion of the state board, provides at least equal benefits may be approved in lieu thereof. Full-time teachers assistants and teachers aides shall be granted minimum annual sick leave of 10 school days.
