Chapter 11

RESOLVE, for Laying of the County Taxes for the Years Nineteen Hundred and Sixty-nine and Nineteen Hundred and Seventy.

Emergency preamble. Whereas, the several counties hereinafter named have certain expenses and liabilities which must be met as they become due; and

Whereas, it is necessary that the taxes for the year 1969 hereinafter mentioned be immediately assessed, in order to provide the required revenue for the several counties; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

County taxes apportioned. Resolved: That the sums appearing opposite to the names of the counties in the following schedule are hereby granted as a tax on each county respectively, to be appropriated, assessed, collected and applied to the purposes of paying debts and necessary expenses of the same and for purposes of law, for the year 1969 and 1970, except that such sums as relate to 1970 shall be reduced by the amounts made available by the Revised Statutes, Title 30, section 408.

The foregoing figures represent the total amount of taxes authorized for each year of the biennium. These figures are based upon budgets approved by the Legislature and filed in the Office of the Secretary of State. The Secretary of State upon this resolve becoming effective shall forward to the chairman of the commissioners of each county, a certified copy of each county's budget in summary form and shall provide specific total amounts for personal services, contractual services, commodities, debt service, capital expenditures and contingent.

The county commissioners of each county are granted, where necessary, the authority to appropriate, assess and collect in the year 1970 such additional tax as will enable them to restore the contingent account to its established amount as specified in the budgets approved by the 104th Legislature. Before such additional tax may be levied the county commissioners shall transfer to the contingent account those funds described in the Revised Statutes, Title 30, sections 252 and 408.

No part of the funds herein appropriated shall be expended for obtaining the services of county advisory organizations.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

Chapter 12

RESOLVE to Change the Name of Plantation 33, Hancock County, to Great Pond Plantation.

Plantation 33; name changed. Resolved: That the name of Plantation 33, Hancock County, is changed to Great Pond Plantation.

Effective October 1, 1969

Chapter 13

RESOLVE, Relating to Fishing in Robbins Pond, Aroostook County.

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, fishing is one of Maine's greatest natural resources and tourist attractions; and

Whereas, conservation of fish for both the inhabitants of Maine and our
