## Chapter 53

**RESOLVE**, to Reimburse Mr. and Mrs. Laurie E. Mann of Augusta for Property Taken by State.

Mr. and Mrs. Laurie E. Mann; reimbursed. **Resolved**: That there is appropriated from the Unappropriated Surplus of the General Fund to Mr. and Mrs. Laurie E. Mann, of Augusta, the sum of \$771.52 as a full and final settlement for items not compensated by the State for property taken by eminent domain.

## Chapter 54

**RESOLVE**, to Reimburse George Burns of Cambridge for Well Damage by Highway Maintenance.

George Burns; reimbursed. **Resolved**: There is appropriated from the General Highway Fund the sum of \$800 to be paid to George Burns of Cambridge for salt damage to his well caused by maintenance on Route No. 150 in Cambridge.

## Chapter 55

**RESOLVE**, Providing Moneys for Cerebral Palsy Centers for Home Care and Other Purposes.

**Cerebral Palsy Centers; appropriation. Resolved**: That there is appropriated from the General Fund to the Cerebral Palsy Centers in Maine the sum of \$4,000 for the fiscal year ending June 30, 1970 and the sum of \$4,000 for the fiscal year ending June 30, 1971 to be used to help support a program of home care and day care, purchase of self-help aids and assistive devices, provide extension of therapy, and services of therapists and other professionals; said sum to be allocated as follows: \$1,000 to United Cerebral Palsy of Northeastern Maine, Inc., at Bangor; \$1,000 to Mid-State United Cerebral Palsy, Inc., at Augusta; \$1,000 to Cerebral Palsy Association of Greater Portland, Portland; \$1,000 to Cerebral Palsy Association of Central Aroostook County, Caribou.
