Sec. 10. R. S., T. 34, § 851, amended. The 2nd paragraph of section 851 of Title 34 of the Revised Statutes, as amended by section 11 of chapter 192 of the public laws of 1969, is further amended to read as follows:

All of the females specified in subsections 1-A, 2, 3 and 4 shall be detained and confined in accordance with the orders or sentences of the courts and the rules and regulations of the center applicable to each such category.

Sec. 11. R. S., T. 34, § 853, amended. The first sentence of the 2nd paragraph of section 853 of Title 34 of the Revised Statutes, as repealed and replaced by section 18 of chapter 391 of the public laws of 1967 and as amended by section 13 of chapter 192 of the public laws of 1969, is further amended to read as follows:

When any such woman or any female adjudicated to have committed a juvenile offense under Title 15, section 2611, subsection 4, paragraph A-1, or any female adjudicated or convicted under Title 15, section 2719 is ordered committed to the center the court shall not fix the term of commitment to the center.

#### Chapter 122

AN ACT Relating to Group Fishing Permits for Inmates and Patients at State Institutions.

Be it enacted by the People of the State of Maine, as follows:

- R. S., T. 12, § 2301, sub-§ 2, repealed and replaced. Subsection 2 of section 2301 of Title 12 of the Revised Statutes is repealed and the following enacted in place thereof:
- 2. Free permits for inmates and patients at state institutions. The commissioner is authorized to issue free fishing permits covering groups of patients or inmates at any state institution under the control of the Department of Mental Health and Corrections. Any such permits shall be issued on request of the head of any such state institution, shall be effective while such groups are being conducted by a representative of the institution of which any such patients or inmates are residents and while such groups are fishing within a 25-mile radius of the institution of which such patients or inmates are residents.

#### Chapter 123

AN ACT Relating to Turn and Stop Signals on Motor Vehicles.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 29, § 1192, amended. The last sentence of section 1192 of Title 29 of the Revised Statutes, as enacted by section 3 of chapter 248 of the public

laws of 1965 and as amended by chapter 185 of the public laws of 1969, is further amended to read as follows:

If said signals are given by a lamp or lamps, such lamp or lamps shall emit a white to amber light to the front and a red to amber light to the rear for turn signals and red to the rear for stop signals.

#### Chapter 124

AN ACT Relating to Definition of Registration under Motor Vehicle Law.

Be it enacted by the People of the State of Maine, as follows:

- R. S., T. 29, § 1, sub-§ 10-A, amended. Subsection 10-A of section 1 of Title 29 of the Revised Statutes, as enacted by section 4 of chapter 245 of the public laws of 1967, is amended to read as follows:
- ro-A. Registration. "Registration" shall mean the registration certificate, plates and renewal devices issued under the laws of this State pertaining to the registration of vehicles.

#### Chapter 125

AN ACT to Relieve Pollution Resulting from Malt Liquor Sales.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 28, § 757, additional. Title 28 of the Revised Statutes is amended by adding a new section 757 to read as follows:

#### § 757. Malt liquor sales in kegs

The Liquor Commission shall not deny the wholesale or retail sale of malt liquor in kegs or any fractions thereof to any purchaser entitled to purchase malt liquor.
