§ 3060-A. Penalties

Any person convicted of violating any of the provisions of section 1960-A or regulations promulgated thereunder, relating to upland game, shall be punished by a fine of not less than \$50 and in addition thereto by a fine of \$25 for each bird illegally killed, taken or possessed, and such fines shall not be suspended, or by imprisonment for not less than 30 nor more than 90 days, or by both such fine and imprisonment.

Chapter 232

AN ACT Relating to Use of Weapons in the Allagash Wilderness Waterway.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 12, § 674-A, additional. Title 12 of the Revised Statutes is amended by adding a new section 674-A, to read as follows:

§ 674-A. Possession of firearms

It shall be unlawful for any person to discharge within the boundaries of the Allagash Wilderness Waterway, between May 1st and October 1st any firearm, bow and arrow or weapon powered by CO₂ cartridges. This shall not apply to law enforcement officers or persons authorized by regulations of the State Park and Recreation Commission. Whoever violates this section shall be punished as provided in section 674.

Chapter 233

AN ACT Prohibiting the Turning Back of Speedometers or Odometers on Motor Vehicles.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 17, § 1609-A, additional. Title 17 of the Revised Statutes is amended by adding a new section 1609-A, to read as follows:

§ 1609-A. Turning back, tampering or disconnecting speedometers or odometers on motor vehicles

Any person who turns back, tampers with, disconnects or causes to turn back, tamper with or disconnect the speedometer or odometer of any motor vehicle with intent to deceive shall be punished by a fine of not more than \$1,000 or by imprisonment for not more than 11 months, or by both. All motor vehicle dealers and transferors shall certify in writing to the purchaser of a motor vehicle, motor truck or truck-tractor the name and address
