## Chapter 17

### AN ACT to Increase the Borrowing Capacity of the Four Corners Community School District.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the Four Corners Community School District, consisting of the towns of Dyer Brook, Merrill, Oakfield and Smyrna, are in need of new school facilities; and

Whereas, the debt limit imposed on community school districts is unnecessarily restrictive; and

Whereas, the following legislation is necessary to prevent undue hardship on elementary school children in the area; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**Power to borrow money.** The trustees of the Four Corners Community School District, consisting of the towns of Dyer Brook, Merrill, Oakfield and Smyrna, are authorized and empowered to borrow a sum of money not to exceed \$500,000 for the purpose of building elementary school facilities in said community school district notwithstanding any limitations contained in the Revised Statutes, Title 20, sections 351 to 360.

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.

## Chapter 18

### AN ACT Relating to Maine Beer Wholesalers Association, Inc.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, by chapter 360 of the public laws of 1969, the Legislature authorized the retail sale of wine; and

Whereas, the following legislation is vitally necessary to permit Maine Beer Wholesalers Association, Inc. to carry out its duties as wine wholesalers as soon as possible and to render the additional services which were intended by the law authorizing the retail sale of wine; and
