of this Act at said meeting equals or exceeds 10% of the total vote for all candidates for Governor in said town at the next previous gubernatorial election, but failure of approval by the necessary percentage of voters at any such meeting shall not prevent a subsequent meeting or meetings to be held for said purpose within the time limitation of this section.

The result of the vote in said Winterport District shall be declared by the municipal officers of the Town of Winterport and due certificate thereof shall be filed by the clerk of said town with the Secretary of State.

Chapter 144

AN ACT Providing Minimum Retirement Benefits for Certain Teachers.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, there are several former teachers whose service extends back beyond July 1, 1924 and as a result are receiving no pensions at the present time; and

Whereas, the following legislation is vitally necessary to alleviate an inequity which excludes this group of aged former teachers from the current retirement system provisions; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Retirement benefits for certain teachers. The following-named former teachers shall be provided with a minimum retirement benefit of not less than \$80 per month during their lifetime, commencing July 1, 1971:

Sec. 2. Appropriation. There is appropriated from the General Fund to the Maine State Retirement System the sum of \$27,840 for the fiscal year ending June 30, 1972 and \$26,030 for the fiscal year ending June 30, 1973 to carry out the purposes of this Act.

Emergency clause. In view of the emergency cited in the preamble, this Act shall become effective July 1, 1971.

Effective July 1, 1971

Chapter 145

AN ACT to Make Allocations from the General Highway Fund for the Fiscal Years Ending June 30, 1972 and June 30, 1973.

Emergency preamble. Whereas, Acts and resolves passed by the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the said 90-day period will not terminate until after the beginning of the next fiscal year; and

Whereas, certain obligations and expenses incident to the operation of the State Highway Commission will become due and payable on or immediately after July 1, 1971; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Allocation of General Highway Fund. Income to the General Highway Fund for the next 2 fiscal years—from July 1, 1971 to June 30, 1972 and from July 1, 1972 to June 30, 1973—shall be segregated, apportioned and expended as designated in the following schedules:
