## CHAPTER 19

### AN ACT Relating to the Preparation of List of Prospective Jurors.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the efficient operation of the State's judicial system and the procedures for the selection of prospective jurors utilized within that system is important to the well-being of the State of Maine; and

Whereas, it would be beneficial and advantageous for the provisions of this legislation to be effective on such a date so that such provisions would apply to the preparation of the 1973-74 jury lists in the several counties of the State; and

Whereas, the jury commissioners in the several counties should know well in advance as to when their new jury lists for 1973-74 must be completed; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 14, § 1254, amended.** The 3rd paragraph of section 1254 of Title 14 of the Revised Statutes, as repealed and replaced by chapter 336 of the public laws of 1967, is amended to read as follows:

This list shall contain such a number of names of persons as the commissioners shall deem necessary for the number of ~~terms to be served by the jury~~ persons required for jury service in their county for the period of ~~July 1st~~ September 1st through ~~June 30th~~ August 31st.

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.
