All insurance policies and certificates thereof shall be issued by an insurance company licensed by the Insurance Commissioner to do business in the State of Maine.

CHAPTER 276

AN ACT Increasing Nonresident Hunting License Fee.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 12, § 2401, sub-§ 3, §§ E and F, amended. Paragraphs E and F of subsection 3 of section 2401 of Title 12 of the Revised Statutes, as repealed and replaced by section 1 of chapter 409 of the public laws of 1971, are amended to read as follows:

E. Nonresident small game hunting	\$20.50	\$22.50
Permits hunting of all species except bear and deer.		
F. Nonresident big game hunting	\$42.50	\$46.50
Permits hunting for all species including bear and deer.

CHAPTER 277

AN ACT Relating to Additional Roads on Indian Reservations at Pleasant Point and Indian Township.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the roads to be constructed pursuant to this Act will enable the Pleasant Point and Indian Township Passamaquoddy Reservation Housing Authorities to begin construction of 70 units of housing as soon as possible; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety, now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 23, § 1051, amended. Section 1051 of Title 23 of the Revised Statutes, as amended by section 22 of chapter 593 of the public laws of 1971, is further amended by adding 4 new sentences at the end to read as follows:

Additional roads and streets at Pleasant Point and Indian Township proposed by the Pleasant Point and Indian Township Passamaquoddy Reservation Housing Authorities shall be a part of the state highway system if there is a dedication of sufficient land by appropriate authority. The housing authority shall obtain approval from the Commissioner of Transportation for its plans of the proposed roads and streets before dedication. The Department of Transportation shall accept the roads and streets set forth on the approved plans when it finds there has been a lawful dedication of the land designated on the plans. The Department of Transportation is authorized to accept funds, other than funds allocated for the construction of state highways, that may be authorized for implementing the housing authority plans for development, and to contract and do all things necessary to cooperate with other governmental agencies in the construction or the maintenance of these roads and streets.

Sec. 2. Appropriation. There is appropriated from the General Highway Fund to the Department of Transportation, Bureau of Highways, the sum of \$195,000 for the construction of state highways in the Indian Reservations of Pleasant Point and Peter Dana Point. Any balance on June 30, 1974, shall carry forward until the purpose for which the appropriation is made shall be accomplished.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

CHAPTER 278

AN ACT Permitting Savings Banks to Indemnify its Trustees, Officers and Employees.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 9, § 472, sub-§ 7, amended. Subsection 7 of section 472 of Title 9 of the Revised Statutes, as amended by section 8 of chapter 401 of the public laws of 1969, is further amended by adding a new paragraph to read as follows:

A savings bank may make provisions to indemnify its trustees, officers, employees and agents and to purchase and maintain insurance on behalf of any such person pursuant to Title 13-A, section 719. For the purposes of this Title, the word "directors" in Title 13-A, section 719 shall mean trustees and the word "officers" in Title 13-A, section 719 shall mean a person who is or was an officer of a savings bank pursuant to section 473.
