CHAPTER 330

AN ACT Relating to Penalty for Recklessly Causing Death by Operation of a Motor Vehicle.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 29, § 1315, amended. The 2nd sentence of the first paragraph of section 1315 of Title 29 of the Revised Statutes is amended to read as follows:

Any person convicted of reckless homicide shall be punished by a fine of not more than ~~\$1,000~~ \$2,000 ~~or~~ and by imprisonment for not ~~more than 5 years, or~~ ~~by both~~ less than 6 months nor more than 5 years.

Effective October 3, 1973

CHAPTER 331

AN ACT to Effect Economies in Distribution of State Publications.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 1, § 505, additional. Title 1 of the Revised Statutes is amended by adding a new section 505 to read as follows:

§ 505. Mailing lists

All addressees on mailing lists used for the distribution of all matters printed or distributed at state expense by dedicated or undedicated revenues shall at least once in every 12-month period be contacted in writing to inquire if continuance of delivery to said addressees is desired. Failure of the addressee to affirmatively reply within 30 days of the written inquiry shall cause such addressees to be removed from said mailing list. However, nothing in this section shall prevent any printed matter being distributed where otherwise required by law.

CHAPTER 332

AN ACT Relating to Planning Function of the Maine Law Enforcement Planning and Assistance Agency.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 5, § 3350, amended. The 2nd sentence of section 3350 of Title 5 of the Revised Statutes, as enacted by chapter 465 of the public laws of 1969, is amended to read as follows:
