CHAPTER 642

AN ACT to Correct an Inconsistency in the District Attorney Law.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 30, § 551, amended. Section 551 of Title 30 of the Revised Statutes, as amended by section 16 of chapter 567 of the public laws of 1973, is further amended to read as follows:

§ 551. Appointment of temporary substitutes

When the district attorney does not attend a criminal session or the office is vacant, the court may appoint an attorney to perform his duties during the session and allow him a reasonable compensation to be paid from the ~~district~~ county treasury, in the county where said appointment is made, and the justice shall notify the Attorney General who shall deduct the same from the salary of such district attorney and forward the same to such ~~district~~ county treasurer.

Sec. 2. Effective date. This Act shall become effective January 1, 1975.

CHAPTER 643

AN ACT to Permit Hours of Sale of Liquor in Take-out Stores to Correspond with On-premises Establishments.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 28, § 4, amended. The first sentence of section 4 of Title 28 of the Revised Statutes, as amended, is further amended to read as follow:

No liquor shall be sold in this State on Sundays except as hereinafter provided, and no licensee by himself, clerk, servant or agent shall, between the hours of midnight and 6 a.m., sell or deliver any liquors, except no liquors shall be sold or delivered on Saturdays after 11:45 p.m. and except that in restaurants, class A restaurants, taverns, class A taverns, **retail stores**, hotels and clubs liquor may, except as provided, be sold to 1 a.m.
