## CHAPTER 13

### AN ACT Prohibiting Swimming or Bathing in Upper and Lower Hadlock Ponds, Hancock County.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, this would allow swimming in Upper and Lower Hadlock Ponds, Hancock County, during the summer months; and

Whereas, continued swimming could create a health hazard to the town whose drinking water is supplied by this lake; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

Upper and Lower Hadlock Ponds; swimming or bathing prohibited. No person shall swim or bathe in Upper Hadlock Pond and Lower Hadlock Pond, Town of Mount Desert, Hancock County.

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.

## CHAPTER 14

### AN ACT Prohibiting Pollution of Eagle Lake, Hancock County.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, this would allow swimming in Eagle Lake, Hancock County during the summer months; and

Whereas, continued swimming could create a health hazard to the town whose drinking water is supplied by this lake; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the fol-

lowing legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**Pollution of Eagle Lake, Hancock County; prohibited.** No person shall swim or bathe in Eagle Lake, Hancock County.

No person shall operate a boat by rowing, paddling, use a sail or motor and no person shall operate a snowmobile or fish through the ice in that area of Eagle Lake contained within a circle, the center of which is the so-called Gate House of the Bar Harbor Water Company at the Duck Brook outlet of said lake, the radius of which circle is 1,000 feet.

Any person convicted of violation of this Act shall be punished by a fine of not more than \$50 or by imprisonment for not more than 10 days, or by both.

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.

## CHAPTER 15

### AN ACT Prohibiting Swimming or Bathing in Jordan Pond, Hancock County.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, this would allow swimming in Jordan Pond, Hancock County during the summer months; and

Whereas, continued swimming could create a health hazard to the town whose drinking water is supplied by this lake; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**Jordan Pond; swimming prohibited.** No person shall swim or bathe in Jordan Pond on Mount Desert Island, Hancock County.

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.
