ings and return made to the office of the Secretary of State in the same manner as votes for Governor and Members of the Legislature, and the Governor and Council shall review the same, and if it shall appear that a majority of the inhabitants voting on the question are in favor of the Act, the Governor shall forthwith make known the fact by his proclamation and the Act shall become effective in 30 days after the date of said proclamation.

Secretary of State shall prepare ballots. The Secretary of State shall prepare and furnish to the several cities, towns and plantations ballots and blank returns in conformity with the foregoing Act, accompanied by a copy thereof.

CHAPTER 119

AN ACT Appropriating Funds for Replacement Volumes of the Revised Statutes.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, by the last revision of the Revised Statutes it was planned that in the future no more "bulk" revisions, so-called, would be forthcoming but rather a publication of replacement volumes; and

Whereas, at least 2 volumes of the Revised Statutes, namely, those containing the Insurance Code and the Maine Business Corporation Act, have become so bulky and large that efficient use is impaired and therefore these volumes should be republished; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Appropriation. There is appropriated from the Unappropriated Surplus of the General Fund to the office of Director of Legislative Research the sum of \$134,000 to republish replacement volumes of the Revised Statutes. The breakdown shall be as follows:
