## **CHAPTER 14**

RESOLVE, Authorizing the Forest Commissioner to Convey the State's Interest in Lot in Codyville, Washington County, to Clarify Title.

Forest Commissioner to convey lot. Resolved: That the Forest Commissioner is authorized to sell and convey to Dale R. Hamilton of Codyville, Washington County, Maine, for the sum of \$1 the interest of the State in the lot described in the deed from Freeman Cochran to Harry Houghton, dated July 24, 1925 and recorded in Washington County registry of deeds in book 443, page 350, said lot being 160 acres and being a portion of a block of land at one time described as the School Block in a deed from John W. Omar to Lucinda Cochran dated March 5, 1881 and recorded in said registry in book 155, page 200, said transfer to be without cost to Dale R. Hamilton and to be for the purpose of confirming his title to said premises.

### CHAPTER 15

RESOLVE, Authorizing Conveyance of State Land and Easements to City of South Portland for Sewage Collection and Treatment Project.

Conveyance of land to City of South Portland; authorized. Resolved: That the Commissioner of Educational and Cultural Services is authorized to grant and convey by quit-claim deed such fee title to and easements over such part or parts of the land belonging to the State and occupied by the Southern Maine Vocational-Technical Institute in South Portland as may be deemed by said commissioner to be necessary for the extension, improvement or implementation of the South Portland Sewage Collection and Treatment Project. Such conveyances shall be on such terms and conditions as the said commissioner shall decide, subject to the approval of the Governor and Council.

#### CHAPTER 16

RESOLVE, Designating a Certain Bridge Across the Androscoggin River as "The Viet Nam Veterans Memorial Bridge."

"Viet Nam Veterans Memorial Bridge" designated. Resolved: That whereas the Viet Nam War has recently been concluded; and

Whereas, during said war 25 sons of Lewiston and Auburn gave their lives for their country and the cause of peace; and

Whereas, it is the desire of these communities that those who made the ultimate sacrifice during this war should be appropriately remembered; and that the bridge which is part of Maine State Project No. 918-1 (502) be named "The Viet Nam Veterans Memorial Bridge;" and be it further
