RESOLVES
OF THE
STATE OF MAINE
AS PASSED BY THE
One Hundred and Sixth Legislature
1973

Resolved: That the Secretary of State is authorized and directed to cause said Constitution, as amended and arranged, to be enrolled on parchment, or other suitable material and, under the seal of the State, to attest to the correctness of such enrollment; and be it further

Resolved: That the Secretary of State is authorized and directed to cause to be published in pamphlet form copies of the Constitution of the State, in such numbers as he deems necessary, and that one copy of the same be forwarded to the municipal officers of each city and town and to the assessors of each plantation within the State.

Effective October 3, 1973

CHAPTER 30

RESOLVE, to Reimburse William Rich of Buckfield for Loss of Bee Hives by Bear.

William Rich; reimbursed. Resolved: That there is appropriated from the General Fund the sum of \$180 to be paid to William Rich of Buckfield as a full and final settlement of his claim against the State for loss of 4 bee hives and honey destroyed by bear.

Effective October 3, 1973

CHAPTER 31

RESOLVE, to Reimburse Willard M. Judkins of Rangeley for Automobile Damage Due to Highway Construction.

Willard M. Judkins; reimbursed. Resolved: That there is appropriated from the General Highway Fund the sum of \$1,496 to be paid to Willard M. Judkins of Rangeley for damage to his motor vehicle due to highway construction.

CHAPTER 32

RESOLVE, Reimbursing Certain Municipalities on Account of Property Tax Exemptions of Veterans.

Reimbursements to be paid to certain municipalities. Resolved: That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$153,514.80 to pay the following claims presented by municipalities for taxes for the years 1971 and 1972 lost by reason of exemption of veterans, in accordance with the Revised Statutes, Title 36, section 653, subsection I, paragraph H:
