CHAPTER 38**RESOLVE, to Reimburse Norman W. Ahlholm of Warren for Loss of Beehives.**

Norman W. Ahlholm; reimbursed. Resolved: That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$1,482.11 to reimburse Norman W. Ahlholm of Warren as a full and final settlement of his claim against the State for loss of beehives destroyed by a bear.

Effective October 3, 1973

CHAPTER 39**RESOLVE, Providing Funds for Repair of Cathance Lake Dam and Pleasant River Lake Dam, Washington County.**

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, Cathance Lake Dam and Pleasant River Lake Dam are badly in need of repair; and

Whereas, these repairs are vitally necessary to maintain the water flowage in Dennys River to protect the propagation of the spawned Atlantic Sea Run Salmon; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Funds for repair of Cathance Lake Dam and Pleasant River Lake Dam, Washington County; provided. Resolved: That there is appropriated to the Department of Inland Fisheries and Game from the Unappropriated Surplus of the General Fund the sum of \$5,000 to repair the following dams in Washington County:

Cathance Lake Dam	
To replace sheathing, cribbing and baffles	\$3,000
Pleasant River Lake Dam	
To replace sheathing, cribbing and baffles	2,000
	\$5,000

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

Effective July 3, 1973
