## CHAPTER 52

**RESOLVE, to Reimburse David Ervin of Corinna for Property Damages Caused by State Ward.**

David Ervin; reimbursed. Resolved: That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$5,721.39 to be paid to David Ervin of Corinna as a full and final settlement of his claim against the State for damages to his property caused by a state ward.

Effective October 3, 1973

## CHAPTER 53

**RESOLVE, in Favor of Down East Community Hospital of Machias.**

Down East Community Hospital of Machias; reimbursed. Resolved: That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$3,374.90 to be paid to the Down East Community Hospital as a full and final payment and reimbursement for medical and hospital aid extended to certain persons.

## CHAPTER 54

**RESOLVE, to Reimburse Audrey G. Pray of Hersey for Loss of Poultry by Foxes.**

Audrey G. Pray; reimbursed. Resolved: That there is appropriated to Audrey G. Pray of Hersey from the Unappropriated Surplus of the General Fund the sum of \$106 for loss of poultry destroyed by foxes.

Effective October 3, 1973

## CHAPTER 55

**RESOLVE, to Reimburse Vivian Morrison of Dixfield for Property Damage by Highway Construction.**

Vivian Morrison; reimbursed. Resolved: That there is appropriated from the General Highway Fund to Vivian Morrison of Dixfield the sum of \$1,000

to reimburse him for damage to his property caused by the construction of United States Highway No. 2 in Dixfield.

## CHAPTER 56

### RESOLVE, Providing Retirement Benefits Under the State Retirement Law for Earl A. Haines of Brunswick.

**Emergency preamble.** Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, Earl A. Haines has suffered permanent injury and disability arising out of the performance of his duties as a Maine State Police Officer; and

Whereas, the following legislation is vitally necessary to provide Earl A. Haines with those benefits and financial resources to which he would be entitled had he not been so injured; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

**Earl A. Haines; retirement pension. Resolved:** That the trustees of the retirement system are authorized and directed to pay Detective Earl A. Haines retirement at the rate of the current pay of a detective of the Maine State Police; and he is to receive those pay raises to which an active detective may become entitled from time to time for the rest of his life; and he is to receive those medical benefits to which an active member of the Maine State Police is entitled. Payment shall be retroactive to October 13, 1972.

**Emergency clause.** In view of the emergency cited in the preamble, this resolve shall take effect when approved.

## CHAPTER 57

### RESOLVE, Designating Kennebassis Road in Indian Township, Washington County, as a State Road.

**Emergency preamble.** Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, citizens living on Kennebassis Road in Indian Township, Washington County, pay taxes to the State of Maine; and
