A certain lot or parcel of land, with the buildings thereon, situated in Bangor, County of Penobscot, State of Maine, bounded and described as follows, viz: Beginning at the southeast corner of Lot #215 as shown on Plan of Highland Terrace surveyed by P. H. Coombs, recorded in Penobscot Registry of Deeds in Plan Book 6, Page 37; thence southerly along the east line of said Highland Terrace Plan S 9° 08' 35" E one hundred and four hundredths (100.04) feet to a point; thence westerly S 79° 20' 05" W ninety-four and forty-six hundredths (94.46) feet to a point on the east line of Dartmouth Street as established and laid out by the Bangor Council order #188-S passed and effective September 27, 1965 and recorded in the Penobscot Registry of Deeds in Vol. 2074, Page 32; thence northerly along said east line of Dartmouth Street N 10° 39' 55" W one hundred (100) feet to the southerly line of said lot #215; thence easterly along the southerly line of said lot #215 N 79° 20' 05" E ninety-seven and twelve hundredths (97.12) feet to the point of beginning.

This conveyance is made subject to the same conditions, covenants and restrictions as are set forth in a deed from the Urban Renewal Authority of the City of Bangor to Sockbeson Brothers, Inc., dated April 21, 1971, recorded in the Penobscot Registry of Deeds, Vol. 2216, Page 536.

Being all and the same premises conveyed to George F. Burns and Kathleen G. Burns by Richard J. Ward and Lorraine V. Ward dated November 12, 1973 and recorded in the Penobscot County Registry of Deeds.

The purpose of this conveyance is to convey to the within grantees all right, title and interest of the State of Maine in and to the subject premises which it may have acquired by the process of escheat from Lester D. Inman who deceased intestate on November 11, 1961.

CHAPTER 78

RESOLVE, Designating State Route No. 157 and State Route No. 201 in Maine as a Blue Star Memorial Highway.

Resolves, 1947, c. 125, amended. Resolved: That the first paragraph of chapter 125 of the resolves of 1947, as repealed and replaced by chapter 17 of the resolves of 1967, and as amended by chapter 46 of the resolves of 1971, is further amended to read as follows:

That U. S. Route 1 and U. S. Route 1-A starting at the junction of Routes 1-A and 1 in Stockton Springs and extending via Bangor and Brewer to the junction of Routes 1-A and 1 in Ellsworth and that U. S. Route 2 starting at the Maine-New Hampshire border at Gilead and extending to the Maine-New Brunswick border at Houlton and that State Route 3 starting at Augusta and extending to Mount Desert Island and that State Route 157 starting at the junction of Routes 157 and 2 near Mattawamkeag and extending to Millinocket and that State Route 201 extending from Brunswick to the Quebec border in the vicinity of Jackman in Maine be designated as the Blue Star Memorial Highway; and be it further

Resolves, 1947, c. 125, amended. Resolved: That the 2nd paragraph of chapter 125 of the resolves of 1947, as amended by chapter 46 of the resolves of 1971, is further amended to read as follows:

That the Garden Club Federation of Maine is authorized to erect along said highways or in those picnic areas, rest areas or scenic turnouts along said routes that are owned by the State, suitable tablets and ornamentalations, subject to the approval of the ~~State Highway Commission~~ **Department of Transportation**, to perpetuate the memory of the men and women of Maine who served in the Armed Forces of the United States.

CHAPTER 79

RESOLVE, Authorizing the State Tax Assessor to Convey by Sale the Interest of the State in Certain Land in the Unorganized Territory.

State Tax Assessor authorized to convey land. Resolved: That the State Tax Assessor is authorized to convey by sale to Howard C. West, Beryl West and Gerald C. West as tenants in common, for \$979.35, the interest of the State in the following described parcel of land:

ANDOVER NORTH SURPLUS, Oxford County Lots 12, 13 and 14
(Excepting all but $\frac{1}{2}$ interest in common and undivided).

If Howard C. West, Beryl West and Gerald C. West do not pay this amount within 60 days of the effective date of this resolve, transfer to State Bureau of Forestry.

CHAPTER 80

RESOLVE, Authorizing the Maine Land Use Regulation Commission to Enter into License Agreements for Use of its Publications.

Maine Land Use Regulation Commission; authority to enter into license agreements. Resolved: That the Maine Land Use Regulation Commission is authorized to enter into a nonexclusive license agreement on behalf of itself and the State of Maine with Bruce S. Hendler of Cornville, Maine, and such publisher as the commission may in its sole discretion approve, to permit Mr. Hendler to use the art and text of 2 Land Use Information Series booklets, "Subdividing in the Wildlands of Maine" and "Building in the Wildlands of Maine," subject to such terms and conditions as it deems appropriate.

CHAPTER 81

RESOLVE, Authorizing the Commissioner of Mental Health and Corrections to Lease Land in Windham to the Maine State Society for the Protection of Animals.

Commissioner of Mental Health and Corrections; authorized to lease land. Resolved: That the Commissioner of Mental Health and Corrections, in the name of the State of Maine, is authorized to enter into a lease for nominal consideration with the Maine State Society for the Protection of Animals on the following premises:
