**CHAPTER 96****RESOLVE, to Reimburse Edgar W. Tupper of Madison for  
Loss of Beehives by Bear.**

**Edgar W. Tupper; reimbursed. Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$2607.85 to be paid to Edgar W. Tupper of Madison as a full and final settlement of his claim against the State for loss of beehives and honey destroyed by bear.

**CHAPTER 97****RESOLVE, to Reimburse Michael Gilbert of Albion for Loss of  
Poultry by Wild Animals.**

**Michael Gilbert; reimbursed. Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund, the sum of \$3,330 to be paid to Michael Gilbert of Albion as a full and final settlement of his claim against the State for loss of poultry destroyed by wild animals.

Soucy Co. of Fort Kent for Maine cigarette stamps affixed to packages of cigarettes which were unfit for use and consumption and which were returned to the supplier of such cigarettes.
