PREFACE

The following publication entitled "Laws of Maine 1973" consisting of various laws and accompanied by tables, indexes and related state papers is compiled biannually after each regular legislative session pursuant to Title 3, section 164, subsection 6 of the Maine Revised Statutes as an official edition of the session laws of this State.

For the convenience of users, this volume has been arranged in the following manner:

- 1. The table of contents located at the beginning of the volume serves as a general index to the various divisions of the publication. State papers, such as the Senate reapportionment by the Supreme Judicial Court, the initiated bill relating to the form of election ballots and selected memorials, messages, addresses and proclamations of the Governor located by reference to page number in the table of contents.
- 2. A cumulative index, based on the subject index of the 1964 revision, is located at the end of the volume and is arranged by session year and page to show cumulative changes since the last revision.
- 3. Acts of the preceding special sessions are published in the order of their occurrence at the front of the volume and followed by those of the succeeding regular session.
- 4. Located at the top of each page of the chaptered laws is an individual classification and session year of its passage.
- 5. Words deleted from the law, unless repealed by express language, are shown in print with lines drawn through them.
- 6. New words or sections are shown as additions by heavy printing called bold face type 10 point.
- 7. Cross reference tables are provided toward the end of the volume showing the unallocated public laws, the public laws exempted in previous revisions and Titles and sections of the Revised Statutes of 1964 which have been affected to date.

This publication is designed to contain Acts passed at the special session of the 105th Legislature which convened January 24, 1972 and adjourned on March 10, 1972; and Acts of the 106th regular legislative session which convened January 3, 1973 and adjourned July 4, 1973.

Unless enacted as an emergency and effective on the date of the Governor's signature or otherwise noted in the context, all Acts passed at the special session of the 105th Legislature became effective on June 9, 1972 and those Acts passed at the regular session of the 106th Legislature became effective on October 3, 1973.

Biennial revisions of individual departmental laws are not included in this volume, but may be obtained from the respective departments.

This publication has been prepared and arranged with the hope that you, the user, will find it satisfactory.
