## CHAPTER 56

### AN ACT to Amend the Law Relating to the Registration of Automobiles.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, it was the intent of Title 29, section 106, 2nd paragraph, that the registrations for the year 1975 of automobiles expire according to the schedule set forth in section 106, regardless of the date the registration is accomplished; and

Whereas, said section did not accomplish the intended change; and

Whereas, said section has created administrative uncertainties and confusion in interpreting legislative intent; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

29 MRSA § 106, 2nd ¶, as last repealed and replaced by PL 1973, c. 588, § 1, is amended to read:

Registration for the year 1975 of automobiles having plate numbers with a last letter or digit as shown shall be registered ~~before March 1, 1975~~ to expire according to the following schedule:

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.

## CHAPTER 57

### AN ACT to Clarify the Exemption of Hairdressers Holding Booth Licenses from Eligibility for Unemployment Compensation.

*Be it enacted by the People of the State of Maine, as follows:*

26 MRSA § 1043, sub-§ 11, ¶ F, sub-¶ (29), as enacted by PL 1973, c. 471, is amended to read:

(29) Services performed by a hairdresser who holds a booth license and operates a ~~separate business~~ within another hairdressing establishment, if operated under a booth rental agreement or other rental agreement.

Effective October 1, 1975
