CHAPTER 129

AN ACT Relating to the Giving Away of Deer.

Be it enacted by the People of the State of Maine, as follows:

12 MRSA § 2355, sub-§ 5, first sentence is repealed as follows:

~~It shall be lawful for the owner of any legally registered deer to give away not to exceed 1/2 of said deer~~

Effective October 1, 1975

CHAPTER 130

AN ACT to Increase Fees for Overlimit Permits.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 29 MRSA § 1703, 3rd sentence, as amended by PL 1971, c. 593, § 22, is further amended to read:

The fee for such permits shall be not less than ~~\$2~~ \$3 nor more than ~~\$10~~ \$15, to be determined, on the basis of weight, height, length and width, by the Department of Transportation.

Sec. 2. 29 MRSA § 1703, 2nd ¶, last sentence is amended to read:

The fee for such permit shall be based upon a rate of ~~\$10~~ \$15 for each 30-day period covered by the permit.

CHAPTER 131

AN ACT to Delete the Requirement that Taverns Serve Men Only.

Be it enacted by the People of the State of Maine, as follows:

28 MRSA § 2, sub-§ 22, first sentence, as amended by PL 1973, c. 193, is further amended to read:

“Tavern” shall mean a reputable place ~~for men only~~ operated by responsible persons where no food is sold, other than prepared packaged foods, and bar snacks, and no business is carried on except the sale of cigarettes and tobacco products and except the sale of malt liquor at a bar.

Effective October 1, 1975
