CHAPTER 225

AN ACT to Repeal Certain Unconstitutional Provisions of the Election Laws.

Be it enacted by the People of the State of Maine, as follows:

21 MRSA § 247, as enacted by PL 1973, c. 782, § 1-B, is repealed.

Effective October 1, 1975

CHAPTER 226

AN ACT Creating Kennebec County Commissioner Districts.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 30 MRSA § 105-Q is enacted to read:

§ 105-Q. Creation of Kennebec County Commissioner Districts

Kennebec County shall be divided into the following 3 districts:

Commissioner District number one, consisting of the municipalities of Augusta, Chelsea, Pittston, Randolph, Sidney, Vassalboro and Windsor;

Commissioner District number 2, consisting of the municipalities of Belgrade, Farmingdale, Fayette, Gardiner, Hallowell, Litchfield, Manchester, Monmouth, Mount Vernon, Oakland, Readfield, Rome, Vienna, Wayne, West Gardiner and Winthrop;

Commissioner District number 3, consisting of the municipalities of Albion, Benton, China, Clinton, Unity Township, Waterville and Winslow;

Members of the board of commissioners shall be residents of the commissioner district which they represent and shall be elected by the qualified voters of that district.

Sec. 2. **Transition.** The transition of the Kennebec County District system shall be made in the following manner: In 1976 a commissioner shall be elected from district one by the qualified electors of that district. In 1978 a commissioner from district 2 shall be elected by the qualified electors of that district. In 1980 a commissioner from district 3 shall be elected by the qualified voters of that district. Thereafter, elections shall continue in a manner so that each district shall have on the board of commissioners a resident of that district elected by the voters of that district.
