P R E F A C E

The "Laws of Maine" consisting of various laws, indexes, tables and related state papers is compiled and published biennially after each regular legislative session pursuant to Title 3, section 164, subsection 6 of the Maine Revised Statutes as an official edition of the session laws of this State.

This two-volume publication includes Acts passed at the special session of the 106th Legislature which convened January 2, 1974 and adjourned sine die on March 29, 1974 and those Acts passed at the regular session of the 107th Legislature which convened January 1, 1975 and adjourned sine die on July 2, 1975.

For the convenience of users, the following features have been utilized in arranging this publication of the session laws:

1. A table of contents is located at the beginning of the first volume which serves as a general index to the various divisions of this publication. State papers such as reapportionment, public acts suspended by petition and referendum, initiated bills, messages, addresses and proclamations of the Governor and other selected memorials and joint resolutions may be located by reference to page number in the table of contents.
2. Acts of the preceding special sessions are published in the order of their occurrence at the beginning of volume I and followed by those of the succeeding regular session which are continued in volume II.
3. Located at the top of each page of the chaptered laws is the individual classification, year of passage and chapter number.
4. Words deleted from the law, unless repealed by express language, are shown in print with lines drawn through them.
5. New words or sections are shown as additions by heavy printing, otherwise known as bold face type.
6. A cumulative index, based on the subject index of the 1964 revision, is located near the end of the second volume and is arranged by session year and page to show cumulative changes since the last revision.
7. At the end of volume II, cumulative cross reference tables are provided showing unallocated public laws, public laws exempted in previous revisions and Titles and sections of the Revised Statutes of 1964 which have been affected to date.

By terms of the Constitution, Article IV, Part 3, section 16, measures enacted by the Legislature become effective 90 days after adjournment unless enacted as an emergency or otherwise provided. Thus, those Acts taking effect 90 days after adjournment of the first special session of the 106th Legislature become effective on June 28, 1974 and those Acts taking effect 90 days after the adjournment of the regular session of the 107th Legislature became effective on October 1, 1975.

Individual compilations of departmental laws are not included in these volumes, but may be available upon request from the respective departments.

This publication has been prepared and arranged with the hope that you, the user, will find it satisfactory.
