RESOLVES, 1977

4. **Cooperate in analyzing benefit and cost.** Cooperate in an effort to analyze the benefits and costs of providing for fishways on dams or removing dams impeding the reestablishment or expansion of anadromous fish runs and seek funding for such a program; and

5. **Propose legislation.** Propose any legislation needed to aid them in carrying out the objectives of this resolve.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

CHAPTER 40

RESOLVE, Authorizing and Directing the Commissioner of Inland Fisheries and Wildlife to Promulgate Rules and Regulations Pertaining to Ice Fishing.

Commissioner of Inland Fisheries and Wildlife is authorized and directed to promulgate ice fishing regulations. Resolved: That the Commissioner of Inland Fisheries and Wildlife is authorized and directed to exercise his statutory power to promulgate rules and regulations governing ice fishing in the various counties according to the following guidelines.

1. All inland waters of the State shall be classified into categories for the regulation of ice fishing. These 4 categories shall be as follows.

A. Class A. Except as otherwise indicated by special limitations, these waters are open to ice fishing from the time ice forms in the fall until January 1st for all fish except bass, salmon, trout and togue, and open to ice fishing for all fish from January 1st through March 31st.

B. Class B. Except as otherwise indicated by special limitations, these waters are closed to all ice fishing from the time ice forms in the fall until January 1st and are open to ice fishing for all kinds of fish from January 1st through March 31st.

C. Class C. These waters are closed to ice fishing. Class C includes all brooks, streams and rivers except those specifically opened by rule and regulation.

D. Class S. This classification indicates that special limitations exist for this particular body of water. The numbers following the S identify the various special limitations in each county. Special limitations may restrict the general limitations set forth in Class A or B.

- (2) S-2: Open per code B for all fish except smelts. Daily limit of 3 togue and 1 salmon.
- (3) S-3: No size or bag limit on pickerel.
- (4) S-4: Open per code A is that section of the river from the dam at Hackett's Mill (Poland and Minot) to its confluence with the Androscoggin River in Auburn.

- (2) S-2: Open to ice fishing for smelts, from the time the ice forms in the fall until March 31, with night fishing permitted, 3 hooks per line permitted; such hooks to be not less than 4 inches apart.
- (3) S-3: Minimum length of salmon, 14 inches.
- (4) S-4: Boundary waters between Maine and New Brunswick—See

Title 12, section 2554-A (Twenty-third Biennial Revision of Inland Fisheries and Wildlife Laws.)

- (5) S-5: Smelts, perch and pickerel may be taken at night.
- (6) S-6: Daily bag and possession limit on trout: two fish. Ice fishing restricted to 2 lines per person.

B. Special limitations for Hancock County.

- (1) S-1: Minimum length on salmon is 12 inches.
- (2) S-2: No person shall ice fish at said Floods Pond; no person shall engage in or attempt to engage in ice fishing on said Burnt Pond; no person shall engage in or attempt to engage in any recreational activity whatsoever within the area situated between Floods Pond and Burnt Pond. No person shall wash linen or other articles of personal apparel in the waters of either Floods Pond or Burnt Pond. Any person violating this section shall be punished by a fine of not more than \$100 for each such offense.
- (3) S-3: Five fish limit.
- (4) S-4: Use or possession or taking of live fish as bait prohibited.
- (5) S-5: Smelts may be taken only by single baited hook and line.
- (6) S-6: Closed to fishing is that portion of Hatcase Pond lying generally northerly of the red posts set on opposite shores at the narrowest point in the cove at the north end of the pond, this point being about 500 yards south of the pumping station of the Brewer Water District. The remainder of the pond is open to fishing per code B.

18. During any one day of any ice fishing season, no person shall take, catch or kill or have in possession more than 3 fish of the salmon, trout or togue species, or 5 fish of the black bass species, or more than 5 fish or 7½ pounds in the aggregate of salmon, trout, togue or black bass species, except as provided for by special limitations for each county as set forth in this resolve.

During any one day of any ice fishing season, no person shall take, catch, kill or have in his possession more than 8 whitefish, 10 pickerel or 2 quarts of smelts from the inland waters of the State.

19. A person legally licensed may fish through the ice in the daytime with not more than 5 lines, set or otherwise, which shall be under the immediate supervision of such person, in any waters which have been open to ice fishing as set forth in this resolve.

20. A person legally licensed may fish in the nighttime by using not more than 5 lines, set or otherwise, for cusk in waters which have been opened to ice fishing as set forth in this resolve. All lines set for cusk in the nighttime must be visited at least once in every hour by the person setting the same.

21. No person shall have in his possession at any time, except as provided by rules and regulations of the department under the Revised Statutes, Title 12, section 1960, any togue less than 16 inches in length. Unless otherwise specified, the legal lengths and the use or possession of live fish as bait which have been established for open water fishing in each county shall apply to all waters open to ice fishing in those counties.

22. Except as set forth in this resolve, it shall be unlawful to ice fish from ½ hour after sunset to ½ hour before sunrise.
