RESOLVES OF THE

STATE OF MAINE

AS PASSED AT THE

SECOND REGULAR SESSION

of the

ONE HUNDRED AND EIGHTH LEGISLATURE

January 4, 1978 to April 6, 1978

Bureau of Public Improvements; all right, title and interest of the State in and to a certain parcel of land situated in Bangor in the County of Penobscot and State of Maine and comprising a certain lot or parcel of land situated on the northeast corner of a part of the property of the State occupied by the Bangor Mental Health Institute, consisting of 15 acres, more or less, bounded and described as follows: Beginning at a point on the westerly line of Hogan Road at the intersection of Hogan Road and Mount Hope Avenue, thence in a southerly direction along the Hogan Road line for a distance of 1,000 feet, more or less, to a point; thence in a westerly direction along the line of the feeder road that runs from Hogan Road into the Bangor Mental Health Institute for a distance of 400 feet, more or less, to a point; thence in a northerly direction for a distance of 350 feet, more or less, to a point; thence in a westerly direction for a distance of 450 feet, more or less, to a point on the easterly line of the feeder road that runs from Mount Hope Avenue and intersects with the feeder road from Hogan Road; thence in a northerly direction along this feeder road line for a distance of approximately 500 feet, more or less, to a point on the southerly line of Mount Hope Avenue for a distance of approximately 820 feet, more or less, to the point of beginning. The property shall be used only for public purposes.

CHAPTER 64

RESOLVE, Authorizing Cumberland County to Pay Deficits from Unappropriated Surplus.

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the unforeseen transfer of prisoners from York County forced Cumberland County to make additional expenditures in the sheriff's and jail department; and

Whereas, the population of prisoners from York County has increased, while the revenue from York County has not; and

Whereas, these expenses could not have been foreseen in the original Cumberland County budget but must now be met as soon as possible; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Cumberland County commissioners; reimbursement of overdrafts authorized.

Resolved: That the Cumberland County commissioners are authorized to expend from the Cumberland County surplus account the sum of \$139,593.25 to meet overdrafts in the following jail department (1050) accounts:

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

CHAPTER 65

RESOLVE, Authorizing the Commissioner of Educational and Cultural Services to Exchange Certain Lands at Southern Maine Vocational-Technical Institute.

Commissioner of Educational and Cultural Services; authorized to exchange certain lands at Southern Maine Vocational-Technical Institute. Resolved: That the Commissioner of Educational and Cultural Services is authorized to convey to Hague International, a Maine corporation, by quitclaim deed all of the right, title and interest of the State of Maine in the following real estate:

A certain lot or parcel of land situated northeasterly of Pickett Street in South Portland, in the County of Cumberland and the State of Maine.

Beginning at an iron set on the southwesterly line of land conveyed by Ametek, Inc., to the State of Maine by deed dated December 30, 1974, and recorded in the Cumberland County Registry of Deeds in Book 3637, Page 291; said iron set being distant one hundred sixty-one and fifteen hundredths (161.15) feet on a course of North 54° 07' 15'' West from a stone fence post located on the northwesterly line of land conveyed by Greater Portland Public Development Commission to Joseph L. Mayer et al by deed dated September 27, 1952, and recorded in said Registry of Deeds in Book 2112, Page 289, which stone fence post is further identified as the point of beginning for the parcel of land described in the deed from Ametek, Inc., to the State of Maine aforementioned; thence running 54° 07' 15'' West by land conveyed by said Ametek, Inc., to Hague International by deed dated May 28, 1975, and recorded in the Cumberland Registry of Deeds in Book 3719, Page 47, a
