exclusive distributor of those specific brands of alcoholic beverages simultaneously with voluntary or involuntary termination or transfer of these same brands of alcoholic beverages by these breweries, wineries, vintners, brokers and out-of-state wholesalers who obtained the certificate of approval and registered these specific labels and established prices with the Bureau of Alcoholic Beverages. The certificate of approval holder acquiring these brands shall take the place of the certificate of approval holder who appointed these distributors and shall comply with section 653. A violation of this section shall be deemed a violation of the Unfair Trade Practices Act and all remedies provided by that Act shall be available for a violation of this section.

CHAPTER 39

H. P. 354 — L. D. 450

AN ACT to Amend the Per Diem Rate for Persons Serving on the State Board of Nursing.

Be it enacted by the People of the State of Maine, as follows:

32 MRSA § 2155 is repealed and the following enacted in its place:

§ 2155. Compensation

The members of the board shall receive \$50 per day and actual necessary expenses incurred while in performance of their official duties.

CHAPTER 40

H. P. 144 — L. D. 151

AN ACT Concerning County Commissioners' Discretionary Powers Regarding Grants Placed in County Budgets.

Be it enacted by the People of the State of Maine, as follows:

30 MRSA § 253-B, as enacted by PL 1975, c. 654, § 1, is amended by inserting at the end the following new sentence to read:

The commissioners may withhold funds from an agency if there is evidence that funds have been misappropriated or misapplied by the agency.

CHAPTER 41

S. P. 144 — L. D. 320

AN ACT Relating to the Court of Probate of Aroostook County.

Be it enacted by the People of the State of Maine, as follows:

4 MRSA § 305 is repealed and the following enacted in its place:

§ 305. Term of Fort Kent and Caribou probate court

The judge of probate in and for the County of Aroostook shall hold a court of probate at least twice in each year at Fort Kent and at least 4 times each year at Caribou in the county. The time for holding the court shall be appointed by the judge and made known by public notification as provided in section 303.

CHAPTER 42

H. P. 441 — L. D. 558

AN ACT to Expand the Meaning of the Term "Exits" under the Public Safety Laws.

Be it enacted by the People of the State of Maine, as follows:

25 MRSA § 2396, sub-§ 6, as repealed and replaced by PL 1973, c. 632, § 6, is amended to read:

6. Means of egress. ~~The means and adequacy of exits~~ The adequacy of means of egress, in the case of fire, from factories, asylums, hospitals, churches, schools, halls, theaters, amphitheatres, dormitories, apartment or rooming houses, hotels, motels and all other places in which numbers of persons work, live or congregate from time to time for any purpose which comes within the scope of the current edition of the National Fire Protection Association No. 101, Life Safety Code;
