CHAPTER 78

S. P. 164 — L. D. 418

AN ACT to Amend the Professional Service Corporation Act.

Be it enacted by the People of the State of Maine, as follows:

13 MRSA § 713, first sentence, as amended by PL 1975, c. 439, § 1, is further amended to read:

The corporate name of a corporation organized under this chapter shall contain ~~the last names of some or all of the shareholders and shall contain~~ the words “chartered” or “professional association” or the abbreviation “P.A.”, and may contain any other words not specifically prohibited by this section.

CHAPTER 79

H. P. 440 — L. D. 487

AN ACT to Change the Motor Vehicle Laws to Allow Operators to Redistribute their Axle Weight Limits while Traversing Maine’s Interstate Systems.

Be it enacted by the People of the State of Maine, as follows:

29 MRSA § 1654, 5th ¶ from the end, last sentence, as enacted by PL 1975, c. 770, § 157, is repealed as follows:

~~Nothing contained in this paragraph shall permit, validate or in any way apply to the use of the Interstate System as defined in the Federal Aid Highway Act of 1956.~~

CHAPTER 80

H. P. 446 — L. D. 494

AN ACT Concerning Use of Aircraft by Aircraft Dealers.

Be it enacted by the People of the State of Maine, as follows:

6 MRSA § 53, sub-§ 5, last sentence, as enacted by PL 1977, c. 678, § 32, is amended to read:

Nothing in this section shall permit aircraft ~~dealers~~ **brokers** from using aircraft offered for sale for more than 15 months from the date that the aircraft is first offered for sale.

CHAPTER 81

H. P. 103 — L. D. 137

AN ACT Relating to the Raising of Wild Waterfowl in Captivity.

Be it enacted by the People of the State of Maine, as follows:

12 MRSA § 7235, sub-§ 5, ¶ D is enacted to read:

D. Notwithstanding subsection 4, metallic seals are not required for wild waterfowl marked in accordance with applicable federal regulations.

CHAPTER 82

H. P. 387 — L. D. 430

AN ACT to Clarify Lobbyist Disclosure Procedures.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 3 MRSA § 314, first ¶, as repealed and replaced by PL 1979, c. 632, § 1, is amended by adding at the end a new sentence to read:

Joint registrations filed in December of an even-numbered year shall automatically expire on the last day of the following calendar year.

Sec. 2. 3 MRSA § 320, 2nd ¶, first sentence, as reenacted by PL 1975, c. 724, is amended to read:

The Secretary of State shall, no later than December 15th of ~~each~~ **the** year prior
