- Sec. 3. 30 MRSA c. 242, as amended, is repealed.
- Sec. 4. Application. This Act does not affect any bonds, mortgages or transactions issued or entered into prior to the effective date of this Act.
- Sec. 5. Transition provisions. Notwithstanding the Revised Statutes, Title 5, section 1585, any moneys in the Community Industrial Building Fund which are not obligated on the effective date of this Act, and any changes or credits made to the Community Industrial Building Fund on or after the effective date in connection with the financing of a community industrial building under this chapter prior to the effective date, shall be divided equally between rural and urban accounts.
  - Sec. 6. Effective date. This Act shall take effect October 1, 1981.

### CHAPTER 477 H. P. 1104 — L. D. 1309

AN ACT Relating to Burial Expenses for Veterans.

Be it enacted by the People of the State of Maine, as follows:

37-A MRSA § 18, as enacted by PL 1971, c. 580, § 1, is amended to read:

#### 8 18. Grave markers and liners

All grave markers shall be flat type granite as furnished by the Memorial Division, Department of the Army, or flat type granite facsimiles thereof. All boxes used for burial shall be protected with permanent vaults or grave liners. Stones and, vaults and liners shall not be at state expense.
