## CHAPTER 567

S.P. 739 - L.D. 1724

### AN ACT to Adjust the Fees for Licenses Issued by the Arborist Examining Board.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 32 MRSA §2001, last ¶, 2nd sentence, as amended by PL 1965, c. 226, §72, is further amended to read:

Board members not of state agencies shall be paid daily fees of ~~\$20~~ \$25 per day involved, plus current state mileage and living expenses incurred on those days.

Sec. 2. 32 MRSA §2053, first sentence, as last amended by PL 1973, c. 460, §18, is further amended to read:

Applications for examination shall be in writing on forms prescribed by the bureau, shall be notarized and shall be accompanied by the application fee of \$5 ~~\$25~~.

Sec. 3. 32 MRSA §2055, 3rd ¶ is amended to read:

~~Examination~~ Examinations shall be given ~~but at least once a year unless hardship can be proven to the satisfaction of the board at such times and places as the board shall determine.~~ The grading and passing of applicants shall be exclusively the responsibility of the board.

Sec. 4. 32 MRSA §2055, 4th ¶, as amended by PL 1965, c. 226, §75, is further amended to read:

Applicants failing the first examination may apply and take the next or ~~subsequent~~ subsequently scheduled examination upon payment of the required application fee. A no additional fee privilege for a 2nd examination shall extend only through the date of the next annual examination.

Sec. 5. 32 MRSA §2058, last sentence, as repealed and replaced by PL 1977, c. 360, §28, is amended to read:

Lost licenses shall be replaced on application by the licensed arborist and payment of ~~§~~ \$2.

Sec. 6. 32 MRSA §2059, as amended by PL 1977, c. 360, §29, is repealed and the following enacted in its place:

§2059. Fees

A \$25 fee shall accompany each application for examination and shall not be returnable. When an applicant is notified that he is eligible for a license following examination, he shall remit an additional \$20 to cover the biennial license fee of \$20 before a license is issued.

The fee for a biennial renewal license shall be \$20.

## CHAPTER 568

H.P. 1840 - L.D. 1854

### AN ACT Concerning the Preservation of Archaeological Sites.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 27 MRSA §373-A, ~~sub-§8~~, ~~¶A~~, ~~sub-¶(2)~~, as enacted by PL 1981, c. 55, §5, is amended to read:

(2) Posted; or
