CHAPTER 613

H.P. 1800 - L.D. 1790

AN ACT to Provide a Directional Sign at Exit 11 of the Maine Turnpike Indicating
Mt. Abram Ski Area and
Sunday River Ski Resort.

Be it enacted by the People of the State of Maine as follows:

23 MRSA §1201, sub-§34 is enacted to read:

34. Mt. Abram Ski Area and Sunday River Ski Resort. The sign shall be provided by Sunday River Ski Resort and by Mt. Abram Ski Area and constructed, installed and maintained by the Maine Turnpike Authority at exit 11 and shall be worded as follows:

EXIT 11

MT. ABRAM SKI AREA

SUNDAY RIVER SKI RESORT

CHAPTER 614

H.P. 2157 - L.D. 2057

AN ACT to Increase the Sardine Tax.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 36 MRSA §4695, 2nd ¶, as amended by PL 1981, c. 71, §2, is further amended to read:

An excise tax of 40¢ 30¢ per case, as defined in section 4692, subsections 1 to 3, is levied and imposed upon the privilege of packing sardines.

Sec. 2. 36 MRSA §4697, first ¶, first sentence, as last amended by PL 1981, c. 71, §3, is further amended to read:

Every packer shall, on or before the 10th day of each month, report to the State Tax Assessor the quantity of sardines packed by him during the preceding calendar month, on forms furnished by the State Tax Assessor, and pay to the State Tax Assessor the tax of 40¢ got per case on all sardines reported as packed.

- Sec. 3. Effective date. This Act shall take effect on August 1, 1982.
- Sec. 4. Referendum exception. This sardine tax increase shall not be subject to the special industry tax referendum provisions found in the Revised Statutes, Title 36, sections 31 to 35.

Effective August 1, unless otherwise indicated.
