CHAPTER 33

H. P. 167 — L. D. 191

AN ACT Authorizing the Town of Lincolnville to Employ a Superintendent of Schools and Supervising Principal.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Town of Lincolnville; authorized to employ superintendent of schools and supervising principal. Notwithstanding the provisions of the Revised Statutes, Title 20, chapter 7, the Town of Lincolnville is authorized to employ a qualified person to serve as superintendent of schools and as a supervising principal.

Sec. 2. Referendum; effective date. The legal voters of the Town of Lincolnville, Hope and Appleton and of School Administrative District No. 28, Camden and Rockport, shall vote on the following article at properly called referenda to be held within 60 days of the effective date of this Act:

“Shall the voters of the Towns of Lincolnville, Hope and Appleton and of School Administrative District No. 28, Camden and Rockport, authorize the Town of Lincolnville to withdraw from the supervisory union consisting of Lincolnville, Hope and Appleton and School Administrative District No. 28?”

In addition, the voters of the Town of Lincolnville shall vote on the following article:

“Shall the voters of the Town of Lincolnville authorize the school committee to employ a qualified person to serve as superintendent of schools and as a supervising principal?”

The results of the vote on the first article shall be sent to the Commissioner of Educational and Cultural Services who shall add the votes from the Towns of Lincolnville, Hope and Appleton and from School Administrative District No. 28, shall declare the results and shall file a copy of the results with the Secretary of State.

The results of the vote in Lincolnville on the 2nd article shall be declared by the municipal officers of that town, and the town clerk of Lincolnville shall file a certificate of the results with the Secretary of State.

The Town of Lincolnville shall be deemed to be a separate supervisory unit if both of the articles are approved by a majority of the legal voters voting at the election in Lincolnville and the first article is approved by a majority of the legal voters voting at the elections in the Towns of Lincolnville, Hope and Appleton and in School Administrative District No. 28, Camden and Rockport.

If the articles have been approved as set forth in this Act, Lincolnville shall become a separate supervisory unit as of July 1, 1982.

CHAPTER 34

H. P. 1118 — L. D. 1335

AN ACT to Amend the Incorporation of the Town of Poland School District.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the Town of Poland School District is in the process of building an addition to its school building to relieve overcrowding and provide for the safety of its students; and

Whereas, the new building addition and side yard space is vitally necessary; and

Whereas, it is vitally necessary to provide additional open side yard space for a right-of-way and a buffer zone between the right-of-way and the abutting neighbor for the protection and safety of the students; and

Whereas, the Poland School District owns some land not used or useful for school purposes which should be exchanged for other land required for the above expansion; and

Whereas, it is desirable that this matter be acted upon by the earliest possible date; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

P&SL 1953, c. 109, § 8-A is enacted to read:

Sec. 8-A. Authority to exchange property. The Town of Poland School District is hereby authorized to exchange real property owned by it, which the trustees of the district deem of no use for school purposes, for real property which the trustees of the district deem necessary for school purposes. A majority vote of the board of trustees shall be required to authorize such an exchange and to
