- Sec. 4. P&SL 1963, c. 146, § 27, as enacted by P&SL 1963, c. 216, § 2, is repealed and the following enacted in its place:
- Sec. 27. Town of Waldoboro authorized to raise money to contribute to district. Notwithstanding the creation of the Waldoboro Sewer District as a separate entity, the Town of Waldoboro is hereby authorized from time to time to raise and appropriate money for the purpose of providing financial assistance to that district, provided that the amount of the contribution has been voted by the inhabitants of the Town of Waldoboro at any annual or special town meeting, and provided that any payments to the sinking fund from all sources shall be restricted to the levels set forth in section 18.
- Sec. 5. Effective date. Section 4 of this Act shall become effective when approved by the voters of the Town of Waldoboro by referendum, which referendum shall be held before December 31, 1983.

CHAPTER 45

H. P. 1041 — L. D. 1260

AN ACT to Amend the Charters of the Mars Hill Utility District and the Rumford Water District.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P&SL 1911, c. 290, § 9, 6th sentence, as repealed and replaced by P&SL 1971, c. 58, is amended to read:

Each member shall receive in full compensation for his services an allowance of \$300 per annum \$30 for each meeting attended and reimbursement for travel and expenses, up to a maximum of \$400 per year.

Sec. 2. P&SL 1957, c. 143, § 8, 6th sentence, is amended to read:

The trustees shall meet monthly and specially as may be necessary and each shall receive compensation of \$10 \$30 for each regular or special meeting attended; provided, however, that the total annual compensation of each shall not exceed \$300 \$600.
