CHAPTER 8

H. P. 695 - L. D. 809

RESOLVE, Designating the Rest Area on State Route 23 in Dexter as the Harold Keyte Memorial Rest Area. **Preamble.** Whereas, Harold Keyte served in the Legislature from 1965 to 1974; and

Whereas, Harold Keyte served as a member of the Transportation Committee during the same years; now, therefore, be it

Designation of the Harold Keyte Memorial Rest Area. Resolved: That the rest area on State Route 23 in Dexter be designated as the "Harold Keyte Memorial Rest Area;" and be it further

Resolved: That appropriate plaques designating this area may be erected and maintained at no expense to the State and subject to approval of the Department of Transportation.

CHAPTER 9

H. P. 1213 - L. D. 1381

RESOLVE, for Laying of the County Taxes and Authorizing Expenditures of Lincoln County for the Year 1981.

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, Lincoln County has certain expenses and liabilities which must be met as they become due; and

Whereas, it is necessary that the taxes for the year 1981 hereinafter mentioned be immediately assessed in order to provide the required revenue for the county; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Lincoln County; taxes apportioned. Resolved: That the following sum is hereby granted as a tax on Lincoln County to be apportioned, assessed, collected and applied to the purposes of paying debts and necessary expenses of the county as authorized herein, and for other purposes of law, for the calendar year 1981:
