P R E F A C E

The Laws of Maine is a public document promulgated for the purpose of informing the public of official Acts passed by the Legislature. This volume is compiled and published pursuant to Title 3, section 164, of the Maine Revised Statutes Annotated. Included in the volume are all the laws enacted and approved by the One Hundred and Tenth Legislature at the Second Special Session, September 25, 1981, Third Special Session, December 9, 1981, Second Regular Session, January 6, 1982 to April 13, 1982, Fourth Special Session, April 28, 1982 and Fifth Special Session, May 13, 1982.

The Laws are arranged in this volume by chapter sequence and may be cited by category, year, and chapter number; thus: Public Laws of 1981, chapter 1. Features which will facilitate the use of this volume including the following:

1. A table of contents which is designed to assist the user in locating the contents by page reference to major divisions can be found at the beginning of the volume. Selected state papers, together with messages, addresses and proclamations of the Governor, may be located by reference to page number within the table of contents.

2. At the top of each page is a running heading which indicates the individual classification of each law, its year of passage and its chapter number.

3. Words deleted from the law, unless repealed by express language, are denoted by strike-throughs.

4. New words or sections are denoted by underlines.

5. Citations to a legislative document are provided beneath the chapter number to assist in locating the source documents for sponsors, amendments, statement of intent, etc.

6. The effective date of all nonemergency laws passed at each session of the 110th Legislature, unless expressly provided otherwise, are as follows:

Second Special Session — December 25, 1981

Third Special Session — March 10, 1982

Second Regular Session — July 13, 1982

Fourth Special Session — July 29, 1982

Fifth Special Session — August 12, 1982

Individual revisions of departmental laws are not included in the "Laws of Maine" but may be available upon request from the respective departments.

This volume has been prepared and arranged for the user's convenience and any comments or suggestions to improve the publication are welcomed.
