#### 268 CHAP. 106

Be it enacted by the People of the State of Maine as follows:

10 MRSA §1652, as amended by PL 1979, c. 541, Pt. A, §94, is further amended to read:

#### §1652. Regulation of sale of certain oils

No person shall <u>may</u> sell or keep for sale, except for remanufacture or as provided, kerosene, range oil, fuel oil or other burning oil for illuminating, heating or cooking purposes which will flash at a temperature of less than 115° 100° Fahrenheit, to be ascertained by the application of any standard approved closed cup tester. Nothing contained in this section shall may prohibit the sale or keeping for sale of gasoline or naphtha as such for fuel or illuminating purposes.

#### CHAPTER 107

#### S.P. 151 - L.D. 442

AN ACT Raising the Limit on Speeding Violations which can be Processed by the District Court Traffic Violations Bureau.

Be it enacted by the People of the State of Maine as follows:

4 MRSA §164, sub-§12, ¶B, as amended by PL 1975, c. 770, §12, is further amended to read:

B. The Chief Judge shall by order, which may from time to time be amended, suspended or repealed, designate the traffic offenses within the authority of the violations clerk. Such <u>The</u> offenses shall not include:

- (1) Driving to endanger;
- Reckless driving;
- (4) Offenses resulting in accident;

(5) Operating while under the influence of intoxicating liquor or a narcotic drug or while impaired;

(6) Driving after suspension or revocation of operator's license;

(7) Operating without a license;

(8) Operating an unregistered motor vehicle;

(9) Passing a stopped school bus;

(10) Exceeding the speed limit by more than
15 29 miles per hour;

(11) Loaning or altering license or permit;

(13) Leaving the scene of an accident;

(14) Taking a motor vehicle without consent;

(15) Homicide or assault committed by means of motor vehicle;

(16) Failure to report an accident;

(17) Passing on hills and curves.

The court shall establish schedules, within the limits prescribed by law, of the amount of fines to be imposed for such the offenses. The order of the court establishing the schedules shall be prominently posted in the place where the fines are paid. Fines and costs shall be paid to, receipted by and accounted for by the violations clerk in accordance with these provisions.
