Be it enacted by the People of the State of Maine as follows:

12 MRSA §7080 is enacted to read:

§7080. Incentive for early purchase of 1985 licenses

Hunting and fishing permits or licenses for the calendar year 1985 may be purchased between September 1, 1984, and December 1, 1984, for the same fee as a 1984 license or permit.

Effective July 25, 1984.

CHAPTER 793

H.P. 1697 - L.D. 2251

AN ACT to Amend the Restitution
Provisions of the Victims' Bill of Rights.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 17-A MRSA §1323, sub-§1, as repealed and replaced by PL 1983, c. 352, §3, is amended to read:

1. Inquiry as to victim's financial loss. The court shall, whenever practicable, inquire of a prosecutor, police officer or victim with respect to the extent of the victim's financial loss, and shall order restitution where appropriate. The order for restitution shall designate the amount of restitution to be paid and the person or persons to whom the restitution will be paid.

Sec. 2. 17-A MRSA §1330, sub-§§1 and 2, as enacted by PL 1983, c. 352, §4, are repealed and the following enacted in their place:

1. Work program; payment of restitution. No prisoner who has been ordered to pay restitution may be released pursuant to a work program administered by the Department of Corrections under Title 34-A, section 3035, or a sheriff under Title 30, section 1804, unless he consents to pay at least 25% of his gross weekly wages to the victim until such time as full restitution has been made. The chief administrative officer of the correctional facility where the prisoner is incarcerated shall collect and disburse to the victim or victims that portion of the

prisoner's wages agreed to as payment of restitution. If the victim or victims ordered by the court to receive restitution have died or cannot be located, the correctional facility shall inform the court that ordered restitution. The court shall determine the distribution of these funds.

2. Payment of restitution from other sources. Any prisoner, other than one addressed by subsection 1, who is able to generate income, from whatever source, shall pay 25% of that income to any victim if the court has ordered that restitution be paid. The correctional facility in which the prisoner is incarcerated shall collect and disburse to the victim or victims that portion of the prisoner's income ordered as restitution. If the victim or victims ordered by the court to receive restitution have died or cannot be located, the correctional facility shall inform the court that ordered restitution. The court shall determine the distribution of these funds.

Effective July 25, 1984.

CHAPTER 794

S.P. 862 - L.D. 2342

AN ACT to Clarify Certain Portions of the Reapportionment Laws.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 21 MRSA §1571-B, sub-§5, House Districts Number 1 and 2, as enacted by PL 1983, c. 93, §5, are amended to read:

District Number 1, in the County of York, consisting of that portion of the Town of Kittery enclosed by a line described as follows: Beginning at the Eliot-Kittery boundary and its intersection with Dennett Road; thence east on the Dennett Road to Eliot Road; thence east on the Eliot Road to its intersection with the Route 1 bypass, Blue Star Memorial Highway; thence southwest along the Route 1 bypass to the Maine-New Hampshire border; thence south along the Maine-New Hampshire border to a point due south of Spruce Creek; thence north along Spruce Creek to Crockett's Brook; thence east along Crockett's
