CHAPTER 49

S.P. 296 - L.D. 911

AN ACT to Reinstate the Large Print Book Program at the Maine State Library.

Be it enacted by the People of the State of Maine as follows:

Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

These funds will provide financial support for the Large Print Book Collection which serves Maine's elderly and visually impaired, through the addition of a Clerk Typist III position for the Maine State Library and an increase in the large print book purchasing budget.

H.P. 1230 - L.D. 1633

An Act Appropriating Money for Research and Development of Appropriate Turbine Technology.
