CHAPTER 406

H.P. 800 - L.D. 1130

AN ACT to Permit Limited Operation of Woods Vehicles on State Highways.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 29 MRSA §255, as amended by PL 1981, c. 49, is further amended by adding at the end a new paragraph to read:

No registration or license may be required for a converted motor vehicle used as a woods tractor when the woods tractor is used solely for logging purposes, and the woods tractor may be operated, without registration or license, from or to the premises where the woods tractor is kept, to or from a wood lot and between wood lots, used for logging purposes by the owner of the woods tractor. The woods tractor may be operated, without registration or license, from or to a filling station garage for gas, oil or repairs.

Sec. 2. 29 MRSA §2506, sub-§9 is enacted to read:

9. Converted motor vehicles; woods tractors. Converted motor vehicles which are used as a woods tractor and which are operated within a 10-mile radius of the farm where the vehicle is customarily kept or in the immediate vicinity of the work site where wood is being harvested. Woods tractors qualifying under this subsection shall be permitted to operate in daylight hours only and shall be subject to a partial inspection consisting of running gear, steering mechanism, brakes, exhaust system and section 1371-A, subsection 1, paragraph B.

Effective September 19, 1985.

CHAPTER 407

H.P. 1019 - L.D. 1472

AN ACT to Require the Reporting of Factors Contributing to the Causation of Cancer.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 22 MRSA §1402, first ¶, as amended by PL 1975, c. 293, §4, is further amended to read:

All hospitals shall report to the Department of Human Services all persons diagnosed as having a malignant tumor no later than 30 days from the date of diagnosis or from discharge from a hospital. The report shall include information on the person's usual occupation and industry of employment.

Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Provides funds for a 1/2 time Senior Nosologist and a 1/2 time Clerk Typist II, along with necessary support, to maintain the cancer registry.

CHAPTER 408

H.P. 634 - L.D. 902

AN ACT Relating to Coyote Control.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 12 MRSA §7013, sub-§7-A is enacted to read:
