Sec. 5. Adjustments to allocations. Allocations may be increased or adjusted by the State Budget Officer with the approval of the Governor to specifically cover those adjustments determined to be necessary under any salary plan approved by the Legislature, and those reclassifications and range changes which have been approved by the Department of Personnel, or its successor, and submitted for legislative review prior to the effective date of this Act.

Sec. 6. Exclusion. Exclusive of the provisions of sections 1 to 5, in addition to the amounts authorized by Private and Special Law 1985, chapter 27, up to \$52,000 for capital expenditures may be expended during the fiscal year ending June 30, 1987, for items related to establishment of an additional State Liquor Store in York and for the purchase of modems to connect the new point of sale cash register system to the main frame.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

Effective May 8, 1987.

#### CHAPTER 16

H.P. 613 - L.D. 831

AN ACT to Extend the Time for the Rangeley Water District to Purchase the Rangeley Water Company Plant.

Be it enacted by the People of the State of Maine as follows:

P&SL 1983, c. 89, §19 is enacted to read:

Sec. 19. Extension of time to acquire Rangeley Water Company. The operativeness of this chapter is reinstated and the time provided for the district to acquire the plant, property, franchises, rights and privileges owned by the Rangeley Water Company as specified in section 17, or to file a petition pursuant to section 12 for taking the same, is extended to March 31, 1988.

Effective September 29, 1987.

#### CHAPTER 17

H.P. 988 — L.D. 1333

AN ACT to Make Allocations from the Public Utilities Commission Regulatory Fund and the Public Utilities Reimbursement Fund for the Fiscal Year Ending June 30, 1988, and June 30, 1989.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjourn-

ment unless enacted as emergencies; and

Whereas, the 90-day period may not terminate until after the beginning of the next fiscal year; and

Whereas, certain obligations and expenses incident to the operation of the department will become due and payable on or immediately after July 1, 1987; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

Sec. 1. Allocation of Public Utilities Commission Regulatory Fund and the Public Utilities Commission Reimbursement Fund. Income to the Public Utilities Commission Regulatory Fund and the Public Utilities Commission Reimbursement Fund for the next 2 fiscal years, from July 1, 1987, to June 30, 1988, and from July 1, 1988, to June 30, 1989, shall be segregated, apportioned and disbursed as designated in the following schedule.
