CHAPTER 150

H.P. 1966 — L.D. 2663

AN ACT to Provide Funds for Safe Collection and Disposition of Obsolete Pesticides.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the disposition of obsolete household pesticides poses a serious and immediate threat to the environment of this State; and

Whereas, the indiscriminate dumping of such wastes must be stopped by providing emergency funding for safe collection and disposal services on a statewide basis; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Board of Pesticides Control	
All Other	\$100,000
Provides emergency funds to the Board of Pesticides Control for the safe collection and disposal, on a statewide basis, of hazardous household, agricultural and commercial wastes that have been banned by federal law. In administering this program, the board shall make all reasonable efforts to assure that those parts of the State which were not previously served by this program are given priority.	

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

CHAPTER 151

H.P. 1997 — L.D. 2699

AN ACT to Authorize the Department of Mental Health and Mental Retardation to Reimburse Extraordinary Costs for Special Needs.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, there is need for an ongoing program of day treatment and residential care services immediately for severely handicapped persons not now eligible for services under this program; and

Whereas, the Department of Mental Health and Mental Retardation is unable to provide the necessary services within its current resources; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

<u>MENTAL HEALTH AND MENTAL RETARDATION, DEPARTMENT OF</u>	
Community Mental Health Services	
All Other	\$60,000
Funds to be used to develop an ongoing in-state community day treatment and residential program for severely handicapped persons who suffer from deafness and mental illness or retardation, or both, and who are not now eligible for other programs as follows: \$30,000 for personal care assistant, day treatment and interpretive services; and \$30,000 for residential services. If any person receiving services under this Act becomes eligible for Medicaid services, then that portion of unused funds shall lapse to the General Fund. If the program is not developed by the department within 90 days of the effective date of this Act, then these funds shall be used to pay the costs of out-of-state treatment for persons eligible for services under this Act until such time as an in-state program is developed and available.	

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.
