### PREFACE

Volume 3 of the 1987 *Laws of Maine* contains all the session laws enacted or approved at the Third and Fourth Special Sessions of the 113th Maine Legislature and all private and special laws, resolves and a selection of related legislative messages, proclamations and resolutions for the biennium of the 113th Legislature.

The derivation of each chaptered law precedes the title, indicating both the House or Senate Paper number and legislative document number for reference purposes. The effective date is located at the end of each chapter.

This volume of laws has been compiled and published pursuant to the Maine Revised Statutes, Title 3, section 163-A, subsection 3.

Volume 3 includes a subject matter index for only the legislation included in this volume. A cumulative index covering the entire 113th Legislature and earlier bienniums will be published in the near future.

Individual revisions of departmental laws are not included here but may be available upon request from the respective departments and agencies. Also, copies of a specific chapter of a law may be obtained by contacting the Engrossing Division of this office.

This volume has been prepared for the convenience of the people of the State of Maine and any comments or suggestions for improvements in subsequent editions would be appreciated.

Finally, it should be noted that David S. Silsby, Revisor of Statutes for many years, completed his service as Revisor at the end of the Fourth Special Session. He was responsible for the revised format of this publication along with many other innovations, and he will be missed by the staff of this office and by the many Legislators whom he served so well.
