Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Standardized kit. Resolved: That the Department of Human Services and the Department of Public Safety shall review evidence protocols for cases of gross sexual assault and propose a standardized kit for the collection of evidence by hospitals in cases of alleged gross sexual assault; and be it further

Sec. 2. Report. Resolved: That the Department of Human Services and the Department of Public Safety shall submit their report and proposal, along with any necessary implementing legislation, to the Second Regular Session of the 115th Legislature no later than February 1, 1992.

Emergency clause. In view of the emergency cited in the preamble, this resolve takes effect when approved.

CHAPTER 18

H.P. 1328 - L.D. 1919

Resolve, for Laying of the County Taxes and Authorizing Expenditures of Oxford County for the Year 1991

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, Oxford County has certain expenses and liabilities which must be met as they become due; and

Whereas, it is necessary that the taxes for the year 1991 for Oxford County be immediately assessed in order to provide the required revenue for the county; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Oxford County; taxes apportioned. Resolved: That the following sum is granted as a tax on Oxford County to be apportioned, assessed, collected and applied to the purposes of paying debts and necessary expenses of the county as authorized in this resolve,

and for other purposes of law, for the calendar year 1991:

Sec. 2. General Fund expenditures authorized. Resolved: That the following sums, based on the county budget filed in the office of the Secretary of State, are authorized as General Fund expenditures by the county during the calendar year 1991 in the specific amounts of expenditures for personal services, contractual services, commodities and capital expenditures for each account in the county budget:
