RESOLVES

OF THE

- 1. With input provided by the Department of Economic and Community Development and the Department of Education:
 - A. Identify existing innovative educational programs and Maine businesses wishing to work with educators; and
 - B. Provide clearinghouse information to teachers, school systems, businesses, researchers and others requesting information on exemplary educational programs;
- 2. Create regional committees of teachers, business and labor leaders, higher education representatives and private citizens to assist teachers in the development of global and economic education in school programs and curricula;
- 3. Sponsor exhibits of exemplary school programs and help teachers develop resources for development;
- 4. Coordinate and, when practicable, collaborate on programs sponsored by the Maine Council on Economic Education and the Maine Development Foundation;
- 5. Encourage the development of new international exchange programs; and be it further
- Sec. 4. Report. Resolved: That the committee shall report annually to the Legislature and the Governor the results of its efforts, including any recommendations to further the purpose of the committee. The committee shall submit a final report to the Legislature, the Governor and the Office of the Executive Director of the Legislative Council no later than September 30, 1994. The committee may submit implementing legislation with any annual report; and be it further
- Sec. 5. Staff. Resolved: That organizations whose members serve on the committee may provide staff support to the committee, including any clerical support and technical assistance the committee may need to make grant proposals; and be it further
- Sec. 6. Funding; compensation. Resolved: That interested persons and organizations may provide outside sources of funding to finance the activities of the Maine Committee for Global Education. The Legislative Council shall administer any outside funds acquired for the conduct of the study. Expenditures may not be incurred that have an impact on the General Fund. Expenditures may not be incurred relative to this study unless the outside sources of funding have been received by the Legislative Council. Members of the committee are entitled to expenses from any such funding; and be it further

Sec. 7. Repeal. Resolved: That this resolve is repealed on June 30, 1995.

CHAPTER 35

S.P. 697 - L.D. 1862

Resolve, to Establish a Commission to Arrange for the Display of the Flags of Maine's Desert Storm Units in the Hall of Flags of the State House

- Sec. 1. Commission established. Resolved: That a commission is established to arrange for the display in the Hall of Flags in the State House of the flags of the Maine units that participated in the Persian Gulf War; and be it further
- Sec. 2. Commission membership. Resolved: That the commission consists of the following 6 members: two members representing the Disabled American Veterans; 2 members representing the American Legion; and 2 members representing the Veterans of Foreign Wars to be nominated by their organizations and confirmed by the President of the Senate and the Speaker of the House of Representatives; and be it further
- Sec. 3. Duties. Resolved: That the commission shall develop a plan to make arrangements to have the flags of the Maine units that participated in the Persian Gulf War displayed in the Hall of Flags. The commission shall submit its plan to the Legislative Council for review and approval.

CHAPTER 36

H.P. 1310 - L.D. 1892

Resolve, to Establish a Commission to Investigate Census Data Irregularities

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the federal decennial census data collected in 1990 appear to contain irregularities in its population counts for certain towns in the State; and

Whereas, these irregularities need to be examined with dispatch and resolved as soon as possible; and
