Sec. 7. Reimbursement. Resolved: That the members of the commission who are Legislators are entitled to the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2, for days of attendance at commission meetings. All members of the commission who are not state employees are entitled to receive expenses, as defined in the Maine Revised Statutes, Title 5, section 12002, upon application to the Executive Director of the Legislative Council for those expenses; and be it further

Sec. 8. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.

Sec. 1. Steven P. Smith and Ramona Smith; State authorized to make payment of \$47,908.06. Resolved: That the Treasurer of State be authorized to pay to Steven P. Smith and Ramona Smith of Kezar

Falls, in Cumberland County, the sum of \$47,908.06 as compensation for overpayment of gasoline taxes to the State from August 1, 1983 to June 30, 1986.
