CHAPTER 481**H.P. 749 - L.D. 1026****An Act to Reduce the Presumptive Amount for Trafficking in Marijuana from 2 Pounds to One Pound****Be it enacted by the People of the State of Maine as follows:**

Sec. 1. 17-A MRSA §1101, sub-§17, ¶D, as amended by PL 1977, c. 647, §1, is further amended to read:

D. To possess with the intent to do any act mentioned in paragraph C, ~~except that possession of 2 pounds or less of marijuana with such intent shall be deemed furnishing.~~

Sec. 2. 17-A MRSA §1103, sub-§2, ¶B, as amended by PL 1989, c. 850, §3, is further amended to read:

B. A Class C crime if the drug is a schedule X drug, if it is marijuana in a quantity of more than ~~2 pounds~~ one pound or if it is marijuana and the person grows or cultivates 100 or more plants; or

Sec. 3. 17-A MRSA §1103, sub-§3, ¶A, as enacted by PL 1989, c. 924, §8, is amended to read:

A. More than ~~2 pounds~~ one pound of marijuana;

CHAPTER 482**H.P. 480 - L.D. 651****An Act to Expand the Definition of "Aggravated Criminal Mischief" to Make It a Class C Crime to Damage Property by Fire****Be it enacted by the People of the State of Maine as follows:**

Sec. 1. 17-A MRSA §805, sub-§1, ¶C, as amended by PL 1995, c. 434, §1, is further amended to read:

C. Damages, destroys or tampers with the property of a law enforcement agency, fire department or supplier of gas, electric, steam, water, transportation, sanitation or communication services to the public, having no reasonable ground to believe that the person has a right to do so,

and thereby causes a substantial interruption or impairment of service rendered to the public; ~~or~~

Sec. 2. 17-A MRSA §805, sub-§1, ¶D, as enacted by PL 1975, c. 499, §1, is amended to read:

D. Damages, destroys or tampers with property of another and thereby recklessly endangers human life; ~~or~~

Sec. 3. 17-A MRSA §805, sub-§1, ¶E is enacted to read:

E. Damages or destroys property of another by fire, having no reasonable ground to believe that the person has a right to do so, and the property damaged or destroyed is neither a dwelling place as defined in section 2, subsection 10 nor a structure as defined in section 2, subsection 24.

CHAPTER 483**H.P. 953 - L.D. 1316****An Act to Remove Restrictions on Items that May Be Auctioned by Public Broadcasting Stations****Be it enacted by the People of the State of Maine as follows:**

Sec. 1. 28-A MRSA §708-B is enacted to read:

§708-B. Donations to public broadcasting stations

Notwithstanding any other provisions of law, a person licensed in the State as a brewery, winery or wholesaler may donate a gift certificate to purchase its product to a public broadcasting station for the purpose of an auction. Any donation is subject to the following:

1. Bureau notified. The bureau must be notified in writing of any donation to a public broadcasting station by a brewery, winery or wholesaler. The notification must include a description of the donation, the estimated value of the donation and the date on which the donation was made; and

2. Proof of age required. A public broadcasting station must ensure that the recipient of the donated item is 21 years of age or older.
