Sec. 4. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

ECONOMIC AND COMMUNITY DEVELOPMENT, **DEPARTMENT OF**

Administration - Economic and Community Development

All Other \$50,000

Provides a one-time appropriation to the Department of Economic and Community Development for the Southern Maine Economic Development District. This appropriation will match a grant from the federal **Economic Development** Administration for a defense diversification project at the United States Naval Shipyard in Kittery, Maine, including an evaluation of the assets of the shipyard and the development of materials that promote the assets of the shipyard and the Town of Kittery, pursuant to section 1 of this Act. These funds may not be expended unless matched by at least an equal amount from the federal **Economic Development** Administration.

Sec. 5. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

ATTORNEY GENERAL, **DEPARTMENT OF THE**

Attorney General - Contingent

All Other \$200,000

Provides funds to the Department of the Attorney General to be used to meet legal costs related to legal proceedings concerning the location of the United States Naval Shipyard in Kittery, Maine. Unexpended funds do not lapse but carry forward to the next fiscal year. The Attorney General shall provide a report to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs no later than December 31, 2000 and every December 31st thereafter concerning expenses incurred in this program.

H.P. 1687 - L.D. 2393

An Act to Appropriate Funding for the Maine School of Science and **Mathematics for Fiscal Year 1999-00**

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, more funds are necessary on a onetime basis for the Maine School of Science and Mathematics to meet debt service requirements; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Magnet Schools

All Other \$171,000

Provides funds on a one-time basis to be applied toward a principal payment remaining on a \$3,000,000 dormitory at the Maine School of Science and Mathematics.

Emergency clause. In view of the emergency cited in the preamble, this Act takes effect when approved.
