CHAPTER 74

H.P. 1425 - L.D. 1866

Resolve, to Allow the Courts to Utilize the Maine Governmental Facilities Authority to Issue a Bond of \$2,500,000 to Finish the Repairs at the Lewiston District Court

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, additional authorization to issue securities is immediately necessary to finish repairs at the Lewiston District Court; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

CHAPTER 75

H.P. 1455 - L.D. 1952

Resolve, Authorizing the Director of the Bureau of Parks and Lands within the Department of Conservation to Convey a Crossing Easement

Preamble. The Constitution of Maine, Article IX, Section 23 requires that real estate held by the State for conservation purposes may not be reduced or its uses substantially altered except on the vote of 2/3 of all members elected to each House.

Sec. 1. Authority to convey easement.

Resolved: That, under the Maine Revised Statutes, Title 5, section 6209, subsection 6 and Title 12, section 598-A, the Director of the Bureau of Parks and

Lands within the Department of Conservation is authorized to convey for fair market value as determined by an independent appraiser to Irving Woodlands, LLC, a permanent easement in the Town of Van Buren to cross an abandoned railroad right-of-way acquired by the bureau with funds from the Land for Maine's Future Fund and managed as a public, multiple-use trail.

Resolve, Extending the Authority of the Commissioner of Administrative and Financial Services to Convey a Portion of the Kennebec Arsenal in Augusta Pursuant to Resolve 1999, Chapter 56

Sec. 1. Resolve 1999, c. 56, §8, amended.

Resolved: That Resolve 1999, c. 56, §8 is amended to read:

Sec. 8. Sunset provision. Resolved: That this resolve is repealed 3 years from its effective date, except that, with respect to the portion of the Kennebec Arsenal referenced in section 3, subsection 2 of this resolve, this resolve is repealed on June 9, 2005.
